A Message From The State President

We welcome the month of October with great pride as we honor the many accomplishments of our Italian Ancestors and celebrate Italian Heritage Month. Many of our lodges have Columbus Day dinners, participate in parades and festas, and serve many of our traditional Italian dishes at special events. Saving Columbus Day has become a National Issue. At the National Plenary in August, National CSJ Chair Kevin Caira shared that this past year his committee and many Grand Officers and members have had to address the issue of saving Columbus Day in the States of Colorado, Utah, Montana, Pennsylvania, Washington and our own California. National is working on creating an informational Script that we can use to approach our Senators and Congressmen regarding this issue. CSJ is holding a 100 Hungry Lions Raffle. 100 tickets at \$100.00 each will be sold. First prize is \$1,500.00. Contact the Grand Lodge if you wish a ticket. National also will be creating a Public Service Announcement for the month of October on Italian Heritage and Columbus that will be aired next October. Please keep the petitions to "Save Columbus Day" coming in, and if possible attend your local area meetings when this issue is coming up on their agenda. We must become vocal and pro-active on this issue!

I mentioned in my last article that several of your State

Officers would be attending the National Plenary in August at Greenwich, Conn. The following are a few of the highlights from that meeting: Papers were filed and a trademark has been obtained for use of an alternate name so lodges can now use either, "Order Sons and Daughters of Italy in America", (if approved by the members) or keep just "Order Sons of Italy in America". The Logo remains the same thus regalia, pins, etc. will not have to be changed, saving a tremendous amount of money. The National Office wants to create a master list of information on all members (including E-mail addresses) in order to facilitate a more open and direct way of communicating information. Be assured your E-mail address will be secure and not be sold or shared with any other organizations. Our State by-laws were unanimously approved by the Supreme Council and will be published and sent to all lodges within the next couple of months. The National Raffle was held on August 20th. Since only 60% of the tickets were sold, the First Prize was reduced to \$9,000 (won by the Grand Lodge of Florida), one of the five \$1000 prizes was won by (Vera Girolami's grandchildren) Yeah, California! National is in the process of developing a new modern web site that will be in full operation by June 2017. Eventually, all Grand Lodge and Filial Lodges will be able to tap into this program and have their web sites part of the total program.

The Sons of Italy Foundation (our Western Foundation) reported that the 2016 NELA Gala netted \$244.033. Next year's NELA will be held on May 25, 2017 at the Omni Hotel with Past National President Joe Sciami serving as the Chair. offer insurance (thus we must offer mortuary benefits); 990 tax forms must be filed by May 15th yearly and a copy sent to the Grand Lodge Office, who will forward them to National. The next National Meeting will be held in Dallas, TX on February 9-11, 2017.

Increased / Retained Membership at all levels from the Supreme Lodge down to filial lodges is a topic of extreme importance. All things financially, etc. hinge on this topic. We must sell our "Brand"- get out of our comfort zones and try new things! The Supreme Lodge and our Grand Lodge have instituted Incentive Programs to build up our membership. I challenge you all to get out there and bring in at least 1 new member. Just think that would double our membership and could become quite profitable to your lodge and the Grand Lodge. Read the information about the contest in the Il Leone - we have until next April 2017. We must work on building a membership that is worthy of people wanting to join rather than resting upon a reputation that is rapidly disappearing from social consciousness. As the year progresses, may I remind you that it takes all of us working together as a family to support each other, our local lodges, and the Grand Lodge so we can grow and become stronger.

The Grand Council met on September 16th and 17th at the Grand Lodge Building in San Francisco. For a few people it was the first time they had visited our home. During the Building Feasibility Report, several opinions from the committee and other members were shared and debated. We are still waiting on information on tax ramifications. As requested by the delegates at the 2016 State Convention,

information stating the pros and cons of the sale and other pertinent information will be sent to all Lodge Presidents and Recording Secretaries by the end of October to share with their members. Therefore, when ballots regarding this issue are sent out by December 24th your state delegates (who represent you) will be able to vote with a clearer knowledge of the whole picture and your lodge's opinions.

Regarding the Italian Earthquake, send checks for the Italian Earthquake Relief to the Grand Lodge Office who in turn will send them in a lump sum to National. Make checks payable to Western Foundation (put Italian Earthquake Relief in the memo). This qualifies for a tax deduction. We are hoping that the Grand Lodge of California can send \$10,000 to help our Italian Brothers and Sisters in their time of need.

We stroll into another Fall, the time of golden leaves and brisk breezes. Soon it will be time to bring out the fondue bowls and dust off the bagna calda recipe. A steaming hot bath of anchovies mashed with garlic in olive oil is a dish only Italians can really appreciate. Like the story of the Princess and the Pea, our sensitive Mediterranean palette comes to life from the rich scent of garlic curling the room. Anyone can eat Swedish and Norwegian pretty, pale cookies soaked in sugar – it takes a hot blooded Italian to handle bagna calda.





California State Capitol

Much of what we know as government and law has come down to us from the Romans. We call the building where the national or a state legislature operates a "capitol." Many of our legal terms are derived from Latin. "Capitol" is one such term. In ancient Rome the capitol did not refer to a building, but to one of the city's seven hills. It is believed the word "capitol" derived from the Latin word "caput," referring to a "skull" found while laying the foundation of the Temple of Jupiter. The Capitol was located between the Forum and the Campus Martius. For hundreds of years, the Capitol was the political center of the Roman Empire.

The architecture of capitol buildings has also come down to us from the Romans. The California State Capitol at 10th Street and L Street in Sacramento is today home to the state's government offices. The Neoclassical structure was completed between 1861 and 1874. The Capitol and its grounds are listed in the National Register of Historic Places and as a California Historical Landmark.

The style of the building is based on the U.S. Capitol in Washington, D.C. One cornice supports a pediment depicting the goddess Minerva surrounded by Education, Justice, Industry, and Mining. Above the flat roof with balustrade are two drums supporting an impressive dome. The first drum consists of a colonnade of Corinthian columns; the second, Corinthian pilasters. The dome is 210 feet high, and supports a lantern with a smaller dome capped with a gold-leafed orbed finial.

The Latin phrase "Senatoris est civitatis libertatem tueri" (It is the duty of a Senator to protect the liberty of the people) is inscribed along a cornice. Along another cornice appears the Latin phrase "Legislatorum est justas leges condere" (It is the duty of legislators to pass just laws).

On the main floor of the Capitol are commemorative statues and murals, while in the rotunda are exhibits of fine art and historical items. The Capitol is surrounded by a landscaped park that features many trees and plants from around the world.







As many of you knew on September 12th I underwent a radical prostatectomy at Holy Cross Hospital in Fort Lauderdale, FL. Discharged the following afternoon I rested comfortably at home until my follow up appointment Tuesday the 20th to remove the catheter and review the final pathology report.

My doctor informed my that it was "very good news". The tumor did penetrate the prostate but was removed by the DaVinci Robotic Surgery. All surrounding areas seemed clear of cancer making me 75% "cancer free". This simply means we will monitor the situation with PSA scores—the first to come on six weeks---looking to see if there is any future reoccurrence.

I apologize for not being able to reach out to everyone at the beginning but it seemed prudent to extend to you a definitive word from the surgical follow-up visit. To those who did know I thank you for your blessings of prayer, concern and love.

It has been a "lonely journey" that only I myself could traverse. Knowing, however, that scores of caring folks were supporting me I never felt alone. There is a difference between being alone (which I never was) and "feeling lonely" (which I believe is the experience of most people facing life-threatening disease). It is similar to having faith but still feeling fear, anger, depression, etc..

Now the journey continues!
